email)


#### Other information: -

In addition to measuring on time in full (OTIF) and in order to ensure 100& compliance with the requirements set out in this document, we will monitor the following additional details for each delivery/collection: -

Go under the A45, at the next roundabout take first exit – A509. Follow A509 to Rutherford drive in Park Farm Ind. Est, follow Rutherford Drive to Davy Close, GXO building ahead of you.

From M1: - Exit M1 at J15, join A508 towards Wellingborough, after 2 miles, the road changes to the A45, at the roundabout, take first exit – A509. Follow A509 to Rutherford drive in Park Farm Ind. Est, follow Rutherford Drive to Davy Close, GXO building ahead of you.
